Transfer of Ownership: Transfer of Ownership must be registered within 14 days with the Keeper of the Stud Book. The Identity Card, Transfer of Ownership Form and Transfer Fee must be forwarded. The last owner must also notify that the greyhound is no longer his property (Rule 73). Registration in the name of a minor: Where a dog is registered in the name of a minor, the parent or guardian must also sign, thereby undertaking responsibility as if he/she were the owner. (Rule 74).  
 Death of a Greyhound: The Keeper of the Stud Book must be informed of death immediately. The Identity Book must be returned. Where a whelp or a greyhound not individually registered dies, written notice shall be forwarded to the Keeper within 14 days. (Rule 76). Receipt of Identification Card, with transfer noted, may be accepted as receipt of transfer fee. This form must be completed in full, otherwise there will be a delay in registration.
